Horse Trials and Showjumping: maximum heights and spreads at max height in metres:-

**Always refer to the Current PCAV Horse Trials Rules for Jump Heights. **

Conditions of Entry: Entry is conditional upon acceptance of these conditions.

- 1. Entry Fee is \$50 per entry.
- 2. Open Riders must be aged over 14 years \$60
 - All open riders, except PCV current members MUST sign and submit a Public Liability Waiver Declaration form with entry, and if current PCV,EA or HRCAV card cannot be presented the rider must pay an additional \$15.
 - b. The prescribed Day Attendance Fee is due UNLESS you can prove personal Liability cover of at least \$10,000,000 * MUST produce proof
 - Riders without adequate Insurance Cover pay \$15 for Liability Only cover for the duration of the event. (Not personal Medical) and complete the <u>Day Participant Waiver</u>
 - d. PCAV club member cards must be inspected at the secretary's office.

PCAV Insurance Policy specifically states anyone not following PCAV Rules may be left uninsured.

- 3. No refunds after closing date UNLESS VET CERT
- Entering this competition constitutes acknowledgement that PCAV rules apply and acceptance of these rules.
- The organising committee reserves the right to cancel any class or competition; divide any class; alter times; refuse any entry with or without stating the reason.

- 6. Competitors may ride no more than three horses subject to entries on the day, and the conditions of PCAV *Handbook of By-laws* multiple horse rules.
- 7. Complying helmets must be worn, spot checks may occur. Gear Check required all riders pre each phase
- 8. Dangerous riding including going to fast will incur a 25 points penalty.
- 9. Medical Armbands: don't need to be worn.
- 10. Vests to be worn as per PCAV rules
- 11. Riders under eight years of age may not compete, horses must be at least age four, no stallions, colts or rigs.
- 12. Competitor numbers the organising committee will pre-allocate and advise numbers. Competitors may supply their own numbers. However, body numbers must be used for cross-country. Body numbers will be available at the event.
- 13. PCAV Alcohol Policy applies.
- 14. Dogs are prohibited without exception.
- 15. Queries, protests, horse abuse, rules as per the PCAV *Handbook of By-Laws*.
- 16. Lungeing is not permitted at this competition
- 17. Neither the organising committee of this competition nor the PCAV accepts any responsibility whatsoever for any accident, damage, injury or illness to horses, riders, ground spectators or any other person or property.
