Conditions of Entry

1. **Entering this competition constitutes acknowledgement that current PCV rules apply and acceptance of these rules.**
2. **PCV Gear Check rules must be adhered to.** All riders must have a gear check before each phase. PCV Gear Check rules Jan 2021
3. **Complying helmets must be worn.** Current PCV gear rules apply. Complying helmets must be worn – ASSA3838 standard — EN1384 standard plus the VG1 standard, VG1 standard – PAS015 Standard – ARB HS 2012 standard – ASTM F1163 standard
4. **OPEN RIDERS:** Before riding all Non-Pony Club members, and any Pony Club member who cannot show their Pony Club card or prove Pony Club membership must complete the day participant waiver and liability declaration: Non-Pony Club members and PCA/PCV members who cannot prove their PCA/PCV membership must pay \$15 per day of participation unless exempt by way of holding insurance (as per Page 2 -Liability Declaration) with an equine organization or hold their own insurance(proof must be provided) . This waiver must be filled in as part of the online entry
5. PCV Insurance Policy specifically states anyone not following PCV Rules may be left uninsured
6. **Refunds** All refunds are subject to a \$10 administration fee. There shall be no refunds after 14th May 2021 unless notified prior to ride time to office@eventsecretary.com.au and a valid veterinary or doctor's medical certificate is provided within 7 days of notification of scratching.
7. **The organizing committee** reserves the right to cancel any class or competition; divide any class; alter times; refuse any entry with or without stating the reason.
8. **PCV club member cards:** must be handed in to the secretary's office before riding. In accordance with PCV Bylaw 15.7.a .ii Grading must not be corrected or altered at a competition.
9. **Competitors may ride more than one horse competitively subject to ballot of entries.** Preferences will be based on listed order on entry form.
10. **Riders must be prepared** to ride before the allocated time in Dressage/Show Jumping/Cross Country
11. **HT competitors** cannot enter CT on the same mount in a different grade.
12. **Queries, protests, horse abuse rules:** All Queries must be lodged via the completion query form as per the PCV Handbook of By-Laws. Jan 2021. Forms will be available at the office
13. **No Dogs or companion animals allowed except** with organizing committees approval
14. **Competitor numbers:** Competitors may supply their own bridle numbers displayed on both the left and right side of the bridle or saddlecloth numbers displayed on both the left and right side of the saddlecloth. **Body numbers must be used for cross-country, organizing committee will supply body numbers.**
15. **Long hair** must not obscure back numbers at any time.
16. **PCV Alcohol and No Smoking policies** apply.
17. **No stallions, colts or rigs** or mares with foals at foot
18. Neither the organizing committee of this competition nor the PCV accepts any responsibility whatsoever for any accident, damage, injury or illness to horses, riders, ground spectators or any other person or property.
19. **Presentations:** will occur after scores have been posted for 30 minutes
20. **Riders who do not stay for presentation MUST** provide \$3.00 for an envelope & postage and provide address details on the day or they will forfeit their prize/ribbon/rosette.
21. **Scoring:** equals separated as per PCV Handbook of bylaws Jan 2021
22. **PCV lungeing policy applies. Lungeing:** is permitted in enclosed arena. Riders need to be considerate of other riders needing to use the round yard and not use arena for more than 10 min if there are riders waiting.
23. **Cross Country Maps will not be printed.** Copies will be displayed on Facebook, MDHPC website and at the admin area on the day.

There will be limited positions available in each grade due to the restricted car park area and the lack of room to build extra arenas.
