Conditions of Entry: Entry is conditional upon acceptance of these conditions.

Camping is available at \$10 per rider.

- 1. Entering this competition constitutes acknowledgement that PCAV rules apply and acceptance of these rules.
- 2. All open riders, except PCV current members, MUST sign and submit a Public Liability Waiver Declaration form with entry.

Riders without adequate Insurance Cover, or a current PC/EA/HRCAV card cannot be presented, must pay the prescribed fee for Liability Only cover for the duration of the event. (Not personal Medical) and complete the Participant Waiver being \$15. The prescribed Day Attendance Fee is due UNLESS you can prove personal Liability Cover of at least \$10,000,000. *Must produce proof.

- 3. Before riding current PCV club member cards must be presented at the office for inspection.
- 4. For each pony club with more than 3 entries can you please supply a cross country helper. Open riders will need to provide a volunteer. Sign up app will be used to manage volunteers.
- 5. No refunds after closing date except with vet or medical certificate. An admin fee of \$10 will be deducted.
- 6. The organising committee reserves the right to cancel any class or competition; divide any class; alter times; refuse any entry with or without stating the reason.
- 7. Competitors may ride more than one horse, subject to the conditions of PCAV *Handbook of By-laws* multiple horse rules.
- 8. Complying helmets must be worn, spot checks may occur.
- 9. Gear Check: required for all riders before each phase.
- 10. Medical Armbands optional but highly recommended for riders with medical conditions.
- 11. Riders under eight years of age may not compete, horses must be at least age four, no stallions, colts or rigs.
- 12. Competitor numbers All riders must provide their own back numbers and holders. Competitors may supply their own numbers on bridle or saddlecloth on either side of the horse for dressage and show jumping. However, body numbers must be used for cross-country.
- 13. Body protectors are compulsory for Grade 3 and above (refer rule 10.14), highly recommended for other grades in cross country phase.
- 14. All competitors completing Grade 1-3 qualifying course are responsible for ensuring the qualification is correctly recorded on membership card and signed by the DC of the organising club or a zone official. Grades 1-5 must have their qualification recorded on their card.
- 15. Dogs are prohibited without exception.
- 16. Queries, protests, horse abuse, rules as per the PCAV *Handbook of By-Laws*. Protests incur a \$50 fee.
- 17. Neither the organising committee of this competition nor the PCAV accepts any responsibility whatsoever for any accident, damage, injury or illness to horses, riders, ground spectators or any other person or property.
- 18. Lunging is not permitted.
- 19. COVID-19 restrictions in place 1.5M distance at all times. All riders and helpers must adhere to all MDPC COVID-19 policies. Full COVID-19 guidelines will be forwarded to all competitors prior to the event.
- 20. Please pick up all manure and place in bags and leave in front of the clubrooms
